Qualifications

Department of Transport, Tourism and Sport Deck Officer (Fishing Vessel) Certificate of Competency are issued following successful completion of training, sea service and written and oral examinations.

Examinations:

Candidates must complete their ancillary Certificates and written examination before they will be accepted for their oral examinations by the Department of Transport, Tourism and Sport (DTTAS). Examinations are carried out by BIM on behalf of DTTAS to the award of a certificate of Competency as a Deck Officer. BIM holds the written examinations at the National Fisheries College of Ireland, Greencastle, Co. Donegal and the National Fisheries College of Ireland, Castletownbere, Co. Cork.

Duration

The Second Hand Limited programme takes approximately 10 to 12 weeks full time study.

The Second Hand Full takes approximately 16 weeks full time study.

The Skipper Full programme takes approximately 14 weeks full time attendance.
