The Programme

Bord Iascaigh Mhara (BIM) is running a National Water Stewardship Support Programme, developed **specifically for the Seafood Sector**. The programme aims to support designated water champions on site to develop an Origin Green compliant action plan for their business in line with the 5 Steps to Better Water Stewardship framework.

Five Steps to Better Water Stewardship

The programme is anchored on the “Five Steps to Better Water Stewardship”, a framework that provides an actionable approach to rolling out water stewardship across all sites.

- Step 1:** Build initial awareness of water stewardship
- Step 2:** Develop a site level Water Map
- Step 3:** Introduce site level Monitoring
- Step 4:** Undertaking water optimization projects
- Step 5:** Maintain control and benchmark against standards
