

INITIAL GRANT CLAIM

STATUTORY DECLARATION IN RESPECT OF THE BREXIT VOLUNTARY PERMANENT CESSATION SCHEME¹

1. I am [the registered owner/one of the registered owners/a director of the Company who is the registered owner]⁴ of⁵ (the “**Grantee**”). I can confirm that I am authorised by and on behalf of the Applicant to make this declaration and am doing so in relation to an application submitted, by the Grantee, to An Bord Iascaigh Mhara pursuant to the Brexit Voluntary Permanent Cessation Scheme (the “**Scheme**”).
2. I can confirm that the Grantee has surrendered their sea fishing boat licence to the Department of Agriculture, Food and the Marine and the Grantee has permanently removed the vessel from the Irish Fishing Vessel Register.
3. I can confirm that the Grantee has and will comply fully with the rules of the Scheme (“**Scheme Rules**”) and the terms and conditions of Grant Funding (“**Grant Funding**”).
4. I can confirm that all of the information concerning the crew who are entitled to compensation under the Scheme (“**Crew Compensation**”) provided by the Grantee in the application process is true, accurate and complete and in compliance with the Scheme Rules.
5. I can confirm that the Grantee has received 50% of the total compensation sum under the Scheme, with the total monies received amounting to €.....⁶
6. I can confirm that the Grantee has applied the monies received in accordance with the Scheme and in full compliance with the Scheme Rules and Grant Funding. I confirm that
